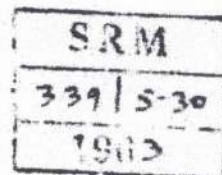
WHEREAS the Sakhar Kanger Sabha, Shirampur, District Ahmednagar, the Representative Union of the Sugar Workers in the local area of Shirampur Taluka in the District of Ahmednagar, a registered Union under the Indian Trade Unions Act, 1962, the Registration No. being 327 has collected some funds and property to the tune of Rs. AND WHEREAS the said Sakhar Kanger Sabha, Shirampur in its General Council Meeting dated 1st August, 1962, has resolved to create a Public Charitable Trust of the said funds and property for the said purpose, according to the said proceedings, we

AND WHEREAS the said Sakhar Kanger Sabha, Shrirampur by
its resolution of the said Council dated 1st August, 1962, has
requested Shri. Gangadhar Rao Ogale and Shri. Ramnarayan Ramdhan
Khatod to become and remain as Life Trustees of the Trust and
the said Shri. Gangadhar Rao Ogale and Shri. Ramnarayan Ramdhan
Khatod have agreed to become and remain such Trustees.

AND WHEREAS the said Sakhar Kanger Sabha, Shrirampur, has
further requested the Managements of :

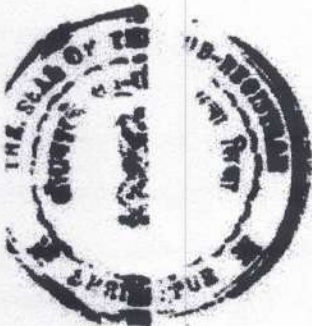
AND WHEREAS the said **Sahakar Kargar Sabha, Shirampur**, has made over to the Trustees, the funds and properties, the particulars of which are set forth in the Schedules "B" and "C" annexed hereto, to be held by the Trustees upon the Trust and in the manner hereinafter expressed.

AND WHEREAS for the purpose of the registration of the said declaration of Trust under Indian Registration Act, 1908, the whole of the assets included under this Trust are valued at Rs. ONE LAKH SEVENTY SIX THOUSAND SEVEN HUNDRED ONE only vide Appendix B & C.

NOW THIS DEED WITNESSETH and it is hereby agreed and declared as follows :-

IN PURSUANCE of the resolution passed by the said **Sahakar Kargar Sabha, Shirampur**, in its General Council Meeting dated 17th February, 1965, and for the considerations aforesaid, the Sabha has granted transfer assign and made over UNTO the said **TRUSTEES** ALL the said funds and properties TO HOLD the same unto and to the use of the Trustees for ever **AND UPON THE TRUSTEES** and subject to the powers and provisions hereinafter declared concerning the same ;

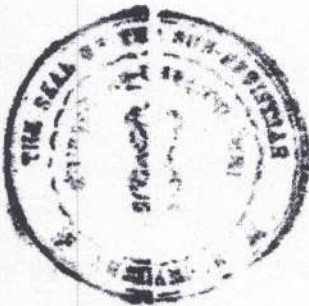

1. The Trust shall be designated as " THE SAKHAR KARGAR HOSPITAL TRUST ".
2. (a) The object of the said Trust shall be to provide medical aid to the people of Shrirampur Taluka of the Ahmednagar District in general on a non-commercial basis and it may provide charitable medical aid to the needy Sugar Workers of Shrirampur Taluka.
(b) The main object of the said Trust shall not be to involve itself into any activity of gaining profit but to serve the community at large.
3. To carry out and fulfil the said objects it shall be lawful for the Trustees;
 - (a) to establish and conduct dispensaries in the Shrirampur Taluka and elsewhere,
 - (b) to start and maintain Hospital, Nursing Homes, Maternity Homes, Sanitariums and the like institutions in the Shrirampur Taluka,
 - (c) to conduct and edit periodical or periodicals for educating the people in respect of their health,
 - (d) to conduct classes and lectures and other educational activities (such as establishing a Medical College) in respect of prevention and cure of the disease in the locality of Shrirampur Taluka,
 - (e) to conduct family planning centres,
 - (f) to promote and encourage such other activities as would be helpful to the maintenance of the health,
 - (g) AND GENERALLY TO carry out and do all other acts, deeds,

4. The First Board of Trustees shall consist of :

- (1) Shri. Gangadhar Rao Ogale, Shirampur, District Ahmednagar.
- (2) Seth Ramnarayan Radhan Khatod, Shirampur, District Ahmednagar.

The above two Trustees shall be LIFE TRUSTEES.

- (3) Shri. Bagaram Tulpale, Bombay,
Nominated by the Sakhar Kargar Sabha, Shirampur.
- (4) Shri. S.D. Punekar,
Nominated by the Sakhar Kargar Sabha, Shirampur.
- (5) Shri. R.G. Jog,

The nominated Trustee shall hold the position of the Trustee subject always however that they do so at the pleasure of the appointing institutions and not otherwise.

The Board of Trustees shall have power to co-opt any person or persons or institutions through their nominees, when the Board

may deem fit for the special services rendered to or to be rendered to the cause of the Trust, but the total number of Trustees including these co-opted trustees shall at no time be less than THREE or more than FIFTEEN.

(5) The Trustees for the time being (hereinafter called " THE TRUSTEES ") shall stand possessed of the Trust Estate moveable and immoveable and the investments and monies, representing the same for the time being upon the Trusts hereinafter contained.

(6) The terms of office of any trustee shall be vacated by :-

- i) Death
- ii) Retirement or resignation,
- iii) Bankruptcy or insolvency,
- iv) Refusal to act as trustee,
- v) Neglect to act as trustee or,
- vi) Absence without leave for three consecutive meetings of the Board of Trustees.
- vii) Otherwise becoming incapable of unfit to act in the Trust
- viii) Or removal by a resolution of the Board of Trustees passed by not less than a majority of three-fourth of the Trustees present.

(7) The Trustees shall, every three years, elect and appoint one of Trustees to be the Managing Trustee. The first Managing Trustee, shall, however, be Shri. Gangadhar Rao Ogale, and he shall act as Managing Trustee for a term of first FIVE YEARS from the commencement of the Trust.

The Main objects and functions of the Managing Trustee shall be among other things :

1. To carry out day to day work of the Trust - Administration.
2. To sign, draw, endorse and negotiate all bills, vouchers, receipts, cheques received, for and on behalf of the Trust.
3. To attend to and conform to all the legal obligations, responsibilities enjoined by the all enactments, rules etc., touching the Trust and its administration.
4. To convene issue notices of the meetings of the Trustees from time to time.
5. To record and keep minutes of the meeting of the Trustees and the sub-committees, if any.
6. To generally superintend the activities of the Trust, the institutions conducted by or on behalf of the Trust and to report from time to time to the Trustees in this behalf.

(8) The Trustees shall, in their first meetings or in any subsequent meeting, elect from among themselves a Chairman of the Board of Trustees.

(9) The Trustees shall be at liberty to form one or more sub-committees consisting of themselves or of one or more of them and such other persons as they may think fit to co-opt from time to time, for the purpose of good Management and administration of the Trust. The Trustees shall be entitled to frame the constitution of such sub-committees as also frame rules and regulations for the management and conduct of the meetings of such sub-committees. The Trustees shall be entitled to delegate to such sub-committees such powers as they may consider proper and desirable and which can be delegated by law for proper administration of the Trust.

(10) The Trustees shall have full and uncontrolled power from time to time to make rules and regulations for the management of the -

of the Trust and the Trust funds and for the conduct of their business and for the custody of securities and frame necessary rules and regulations for the purpose and from time to time - repeal, amend or alter the same.

(11) The Trustees will ordinarily meet at least every three months in every year but that there shall be at least one meeting of the Trustees every year.

(12) Special Meeting of the Trustees may be called at the instance of any four of the Trustees for the purpose of transacting any special business mentioned in the notice, connected with the Trust. A notice of clear three weeks shall be necessary for the same.

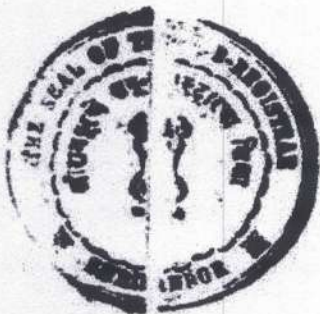
(13) Seven clear days' notice of any meeting, stating the particulars and nature of the business to be transacted at such meeting shall be given to the Trustees SUBJECT NEVERTHELESS that an emergency meeting of the Trustees may be convened with a notice of three days only.

(14) All meetings of the Trustees shall be presided over by the Chairman of the Board of Trustees and in his absence by any one of the Trustees present and elected for presiding over the said meeting.

(15) Every matter relating to the Management and administration of the Trust and any other question which shall arise at the meeting of the Trustees shall be decided by a majority of votes of the Trustees present at the time of voting. In case of equality of votes the Chairman of the meeting shall have a casting vote whether he shall or shall not have previously voted on the question.

(16) The presence of three Trustees shall constitute a quorum for the meeting of the Trustees.

(17) The Managing Trustees shall enter the Minutes of the proceedings of all meetings of the Trustees in a book to be kept for the purpose. The Chairman of the Board of Trust or the Chairman of the meeting, as the case may be shall sign the minutes of the meeting.

(18) The Trustees may invest and keep invested the Trust Funds in any of the Securities guaranteed by the Central Government of the Indian Union or the State of Maharashtra.

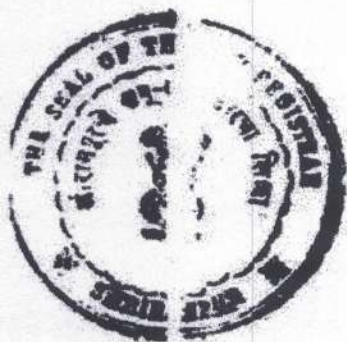
(19) Out of the income, interest, profits and assets of the Trust Estate the Trustees shall, in the first instance, pay and discharge all costs and charges and expenses incurred and to be incurred in or about the administration of the Trust of these presents including the debts of the Trust Estate.

(20) The Trustees may, with a view to accentuate the carrying out of the objects of the Trust hereby declared, accept donations from any person or persons or body corporate, on such terms as they may in their discretion think fit. Such donations shall, unless there is a contrary intention, form part of the Trust Estate and shall be dealt with accordingly.

(21) The Trustees for the time being of these presents shall be respectively chargeable only for such monies and securities as they shall respectively actually receive notwithstanding their respectively signing any receipts for the sake of conformity and shall be answerable and accountable only for their own acts, receipts, neglects, or defects and not for those of each other nor for any banker, broker or other persons with whom any trust monies or securities may be deposited nor for the insufficiency or deficiency of any securities nor for any loss unless the same shall happen through their own

(22) The Trustees have the right to make necessary resolution by circular instead of by meetings and any resolution so agreed to by all the Trustees present in India shall be as valid and effectual as a resolution of the Trustees at a meeting duly convened.

(23) It shall be lawful for the Trustees or Trustee by and out of the monies which shall come to their or his respective hands by virtue of the Trust aforesaid to reimburse themselves, or himself respectively AND ALSO to allow to their co-trustees all costs, charges and expenses which they or any one of them shall or may suffer or sustain about the execution of the Trust and powers of these presents or in relations thereto AND ALSO either before or after the appointment of any new Trustees or Trustee as aforesaid to settle, adjust and allow the account to be wiped off of any old Trustee or Trustees who shall die or go to reside abroad out of India Union for more than twelve months or become Insolvent or be convicted of a criminal offence involving moral turpitude and punished with imprisonment or desire to be discharged from or refuse or become unfit or incapable to act in the said Trust.

(24) The Trustees may, at any time at their absolute discretion, let out or lease any properties comprised in or for the time being forming part of the Trust of these presents either as a whole or in lots or otherwise and for a term and to such person or persons or Institution or Association whether incorporated or unincorporated at such rents and upon such terms and conditions and covenants as they may think proper and accept surrender of leases.

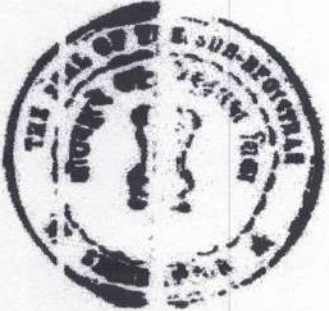

(25) The Trustees shall have power at their discretion to sell or mortgage any of the said properties comprised in these presents of any properties which may for the time being be subject to the trust of these presents with power to buy in or resell the same without being responsible for any loss that may thereby be incurred and in case of any such sale to execute and do any such deeds documents writings acts deeds and things for the purpose of carrying such sale into effect and the Trustees may think necessary in the interests of the Trust and all monies arising from any such sale shall be deemed to be part of the Trust properties and shall be applicable accordingly.

(26) Upon any sale by Trustees under the power of sale aforesaid the Purchaser or purchasers dealing bonafide with the Trustees shall be concerned to see or inquire whether the occasion for exercising or exercising such power has arisen or whether the provisions as to appointment and retirement of Trustees hereinafter contained have been properly and regularly observed and performed. Neither shall the purchasers nor the purchaser be concerned to see to the application of the purchase money.

(27) The Trustees may accumulate the income of the Trust Estate for the time being and from time to time subject to the Trust of these presents or such portion thereof as they may not utilize for any of the objects and purposes of these presents or as is required for the current expenses of the Trust hereof till such time as they may deem fit and invest the same and apply all such investments and accumulations and interest dividends and other income thereof for the objects and purposes mentioned herein when they think fit and proper to do so.
