## HOSTEL ANTI-RAGGING MEASURES

**Date:** 2.10.2025

**Time:** 10:00 AM

**Venue:** Hostel

### Introduction of Anti-Ragging Committee

The meeting began at 10:00 AM sharp with all the students of the **first-year GNM & ANM batch** present in the seminar hall. The faculty welcomed the students warmly and emphasized the importance of the Anti-Ragging Committee. The purpose of forming the committee was explained in detail. It was highlighted that the committee is not just a disciplinary body but also a supportive system to protect students' rights and dignity. Students were also informed that ragging in any form—whether physical, verbal, or psychological—is strictly prohibited on campus, in hostels, and in clinical postings. The committee assured them of **zero tolerance towards ragging** and encouraged them to come forward without hesitation in case of any difficulty.

### Members of Committee

Following the general introduction, the members of the committee were formally introduced:

- **Chairperson:** Mr. Shaikh Ajmoddin – He addressed the gathering with strong words against ragging, encouraging students to uphold discipline and mutual respect.
- **Secretary:** Mr. Ravindra Jagdhane – He explained the reporting mechanisms and documentation processes related to anti-ragging.
- **Incharge of Committee:** Mr. Ashish Gaikwad – He reassured the students about the constant monitoring of campus and hostel premises to ensure safety.
- **Student Representatives:**
  - Mr. Rahul Bhosale
  - Ms. Pooja Gharat
  - Ms. Laxami Salve
  - Mr. Pranav Tupe

### Roles performed by Committee

1. **Prevention and Monitoring:** Regular checks in classrooms, hostels, and clinical areas to ensure no incidents of ragging occur.
2. **Awareness Activities:** Conducting workshops, seminars, and orientation programs for students and parents about anti-ragging laws and ethics.
3. **Counselling:** Providing psychological and emotional support to victims or those struggling with adjustment in the new environment.
4. **Complaint Handling:** Establishing a safe and confidential mechanism for students to register complaints.
5. **Disciplinary Action:** Ensuring strict penalties in case of ragging incidents as per institutional rules and UGC guidelines.
6. **Record Maintenance:** Keeping records of affidavits signed by students and parents, along with online anti-ragging forms.
7. **Promoting Positive Culture:** Encouraging activities that build team spirit, harmony, and collaboration between senior and junior students.

### 5. Responses of Students and Online Anti-Ragging Form Filling

The session received a **very good response** from the first-year students. They listened attentively and interacted with committee members positively. Many students asked questions about safety and reporting procedures, which were addressed satisfactorily by the panel.

### Minutes of Meeting

Meeting commenced with a warm welcome by the faculty. The Chairperson, Mr. Shaikh Ajmoddin, opened the session by highlighting the importance of maintaining discipline and respect in a professional institution like nursing college. He explained the aims and objectives of the Anti-Ragging Committee and the zero-tolerance policy towards ragging. The Secretary, Mr. Ravindra Jagdhane, provided an overview of the reporting mechanisms and documentation processes. The Incharge of Committee, Mr. Ashish Gaikwad, assured the students of constant monitoring of campus and hostel premises. The Student Representatives, Mr. Rahul Bhosale, Ms. Pooja Gharat, Ms. Laxami Salve, and Mr. Pranav Tupe, were introduced. The session received a very good response from the first-year students, who asked questions about safety and reporting procedures, which were addressed satisfactorily by the panel.

committee members were introduced one by one, beginning with the Secretary, Mr. Ravindra Jagdhane, who spoke about procedures for lodging complaints, both online and offline. The Incharge, Mr. Ashish Gaikwad, elaborated on preventive measures and the constant vigilance maintained by the institution. Student representatives were then introduced, who pledged to assist juniors and act as peer-support leaders. Functions of the committee were thoroughly explained. The students were informed about preventive steps, awareness campaigns, disciplinary actions, and counselling facilities. The committee emphasized that ragging in any form is a punishable offense under law and would not be tolerated. Responses of students were very encouraging. They expressed gratitude for the proactive efforts of the committee. The session became interactive as students raised queries, which were addressed patiently. The use of PPT slides during the session helped in presenting information in a structured and easy-to-understand format. The students also participated in online anti-ragging form filling, which was completed smoothly with full attendance. The meeting concluded with a vote of thanks, acknowledging the participation of students and the efforts of the committee. The Chairperson reminded everyone that the institution stands committed to upholding the dignity and safety of all students.
